ANNEX A

I, by my signature below, hereby recognize that my temporary presence in the so-called buffer zone in Nicosia, Cyprus, including but not limited to

➤ the *Cetinkaya* Football Field and vicinity (the “buffer zone”), in order to participate to and/or in connection with the so-called Nicosia Super Special Stage of the Cyprus Rally 2019 to be held in Nicosia on 28 September 2019 (the “Rally”), is solely for my own convenience and benefit or that of my employer and may take place in areas or under conditions of special risk, and in context of United Nations peacekeeping operations.

In consideration of my being temporarily admitted in the buffer zone to participate to the Rally, I, by my signature below, hereby:

- (a) Agree not to touch or enter any building or structure in the buffer zone, with the exception of those strictly related to the above-mentioned events, or otherwise directed to do so by UNFICYP representatives;
- (b) Assume all risks and liabilities during my temporary presence in the buffer zone;
- (c) Recognize that neither the United Nations nor any of its organs (including but not limited to UNFICYP), agency, fund, programme, officials, agents, personnel, servants or employees is liable for any loss, damage, injury or death that may be sustained by me during my presence in the buffer zone and/or participation to the Rally;
- (d) Agree, for myself as well as for my dependants, heirs and estate, to hold harmless the United Nations and all its organs (including but not limited to UNFICYP), agency, fund, programme, officials, agents, personnel, servants or employees from any claim or action on account of any such loss, damage, injury or death;
- (e) Agree, for myself as well as for my dependants, heirs and estate, that in the event that I sustain any loss, damage, injury or death during my presence in the buffer zone and/or participation to the Rally for which the United Nations otherwise may be found to be liable, such liability, if any, shall be subject to the terms of paragraphs 8 and 9 of General Assembly resolution 52/247 of 17 July 1998, whether or not presence in the buffer zone and/or participation to the Rally is carried out in the context of peacekeeping operations and whether or not such terms are otherwise directly applicable by virtue of that resolution.
