- Appendix is valid for FIA Championships, cups, trophies, challenges, series, and international series registered on the FIA international sporting calendar
- Will apply from 1 September 2020 until the FIA repeals it.
- The FIA will keep this COVID-19 Code under review and may amend it from time to time to ensure it remains effective.
- The COVID-19 Code applies to everyone attending the event for any purpose on behalf of a Stakeholder,







- Stakeholders:
- The FIA
- The ASN
- The Organiser
- The Promotor
- Each team (a Competitor) that has entered
- Broadcasters and other media organisations
- Suppliers of products or services to all parties listed above
- Individuals attending on behalf of suppliers of products or services not to all parties are Attendees of the Stakeholder that they are supplying.





COVID-19 Delegate: The COVID-19 Delegate will be the FIA Medical Delegate or (if there is no Medical Delegate at the Event) the Chief Medical Officer.

COVID-19 Symptoms means fever, cough, shortness of breath, fatigue, headache, runny nose (rhinitis), sore throat (pharyngitis), loss of sense of taste or smell, a skin rash, and/or discolouration of fingers or toes.







Profile 1 Attendees: Attendees (every person) who are required to enter high population density working areas at a Venue (e.g., paddocks = service park, bivouac, HQ) (High Density Areas)

Profile 2 Attendees: Attendees who are only required to enter low population density working areas at a Venue (Low Density Areas).







Group means the Profile 1 Attendees affiliated with a particular Stakeholder or who work for a sub-contractor or supplier of the Stakeholder but will be interacting exclusively with that Stakeholder's Profile 1 Attendees during the event

Profile 2 Attendees will not be permitted to enter High Density Areas; and the Venue will be organised to prevent contact at the Venue between Profile 1 Attendees and Profile 2 Attendees.





Pre-Event Test: The Profile 1 Attendee has undergone one PCR Test organised by the Stakeholder in the 96 hours prior to arrival at the Venue,

Fit to Attend means that the *Profile 1 Attendee* has no COVID-19 risk factors that mean they can attend an event. More specifically, confirmation by a Stakeholder that a *Profile 1 Attendee* is Fit to Attendant event means that:

✓ the Profile 1 Attendee has undergone one PCR
Test and the Stakeholder has received a communicati
from the Profile 1 Attendee on the negative test
results;

✓ the Stakeholder has concluded that the Profile 1 Attendee has no underlying health issues or other relevant risk factors specific to COVID-19





PROTOCOLS APPLICABLE AT ALL TIMES

 Each Organiser must implement a Mitigation Plan for High Density Areas that complies with all Applicable Rules and Applicable Laws. Such plan incorporates

temperature checks,

regular and effective washing of hands

 observance of one-way pedestrian systems and/or floor markings to facilitate Social Distancing

an effective system for ensuring only
 Profile 1 Attendees enter High Density Areas

 Stakeholders shall provide their Attendees with copies of the COVID-19 Mitigation Plan

 Stakeholders must devote sufficient resources enable themselves and their Attendees to cor with this COVID-19 Code, including organis

Pre-Event Tests and Medical Face Masks





PROTOCOLS APPLICABLE AT ALL TIMES

Stakeholder must provide the following documents and information to the Organiser, who will store them for six years and provide them to the FIA upon request:

- An up-to-date list of all the Attendees

Confirmation that each listed Profile 1 Attendee is
 Fit to Attend

 Confirmation that each listed Attendee has agreed in writing with the COVID-19 Code

 the name of one of the Stakeholder's Attendees who will be responsible for monitoring the compliance of the Stakeholder's Attendees

Only Attendees on the list for whom all the required information has been provided will be given access to the designated Areas.





PROTOCOLS APPLICABLE PRIOR TO THE EVENT

 Wherever possible, each Stakeholder shall arrange for Attendees travel to the Venue only with members of the same Group.

Individuals will not be admitted to a Venue, even if they hold valid accreditation, unless:

✓ they have confirmed in writing, their agreement to comply with this COVID-19 Code;

✓ their Stakeholder has confirmed they are
Fit to Attend (Profile 1 Attendees only);

✓ they pass any checks (e.g., temperature check) administered by the Organiser;

✓ they wear a Medical Face Mask until they reach a space occupied only by their Group (Profile 1 Attendees only).





PROTOCOLS APPLICABLE **DURING** THE EVENT

- Any time that Profile 1 Attendees spend outside the Venue, must keep interaction with persons outside his Group to a minimum.
- While outside the Venue, Attendees shall observe appropriate mitigation measures specified.
- Each Profile 1 Attendee must:
 - keep to a minimum any interactions with any members of other Groups;
 - wear a Medical Face Mask whenever in a space that is not exclusively used by members of their Group (e.g., scrutineering area);
 - keep to a minimum his/her use of any facilities or services that are also open for use by members of another Group.





PROTOCOLS APPLICABLE **DURING** THE EVENT

- Each Attendee must report immediately if any circumstances arise that may mean he/she is no longer Fit to Attend
- Thereafter the Attendee must comply with the instructions of the COVID-19 Delegate.







PROTOCOLS APPLICABLE AFTER THE EVENT

 Stakeholders shall arrange for Attendees to travel away from the event only with members of their Group.

If an Attendee develops any COVID-19 Symptoms or tests positive for the COVID-19 virus within 14 days of the end of an event, he/she must report this immediately to his/her Stakeholder





2020 FIA REGIONAL RALLY SPORTING REGULATIONS

Nothing in this COVID-19 Code is intended to compromise the application of:

- The rules and regulations that govern the event, and any other regulations specific to or otherwise applicable to the Competition in question or
- the transnational, national, and local laws and regulations that apply to the event, including laws and regulations relating to COVID-19
- The applicable rules and the applicable laws take precedence over this COVID-19 Code.
- All safety measures and all other safety requirements take precedence over the requirements of the COVID-19 Code.
